Who can register to vote?

- ◆ Citizen of the United States
- ◆ Age 18 years on or before the next general election day (Nov. 8, 2016)
- ◆ Legal resident of the county where you plan to vote for 30 days before the election
- ◆ Not currently incarcerated, on probation, or on parole for a felony conviction



How do we register?

- ◆ Fill out a NC Voter Registration Form (available online, libraries, DMV).
- ◆ Mail it to the County Board of Elections at least 25 days **BEFORE** the election.
- ◆ Even if driver's license or last 4 numbers of the ssn is on the form, ID **IS** required in 2016.



Instructions for completing the NC Voter Registration Form

- ◆ Use pens with Black or Blue ink only
- ◆ MUST complete sections marked in red (1, 2, 3 and 4)
- ◆ MUST sign and date
- ◆ ID number (NC ID card or drivers license or last 4 of the Soc. Sec. #)

- ◆ Turn in all the forms even if parts are not completed
- ◆ Mail the forms to County/NC Board of Elections within 7 days of completions.

1. Choose the right time and location
2. Get permission to conduct the drive
3. Have plenty of supplies: registration forms (English & Spanish) clipboards, pens (Blue and Black ink only), signs, stickers, candy!
4. Engage voters: May I help you update your registration? Be polite, friendly and kind!
5. Recruit volunteers and train them



6. Be non-partisan: LWV is a non-partisan
7. It is illegal to pre-fill out the party affiliation
8. Offer to fill out the form for people and let them sign
9. Go over the forms with the people to make sure it is *legible and properly filled out*
10. Turn in all forms: it is illegal to fill in forms once the registrant has left

After Registering Voters

- ◆ Mail completed forms to County/NC Board of Elections within 7 days of completions.
- ◆ Inform Registrants they should receive voter registration card from county Board of Elections.
- ◆ Registrant may get a letter/phone call asking for more identifying info *if* the Board of Elections can't verify identity based on info on the voter registration form.

This is why Section 3 of the form is so important

Voting by Absentee Ballot

- ◆ Any registered voter can vote by mail. No excuse is needed. A voter who does not have the correct ID (2016 and later) can still vote absentee.
- ◆ If a registered voter is a patient in a hospital or nursing home, staff or other non-relative may not assist with requesting or submitting ballot. Near relative may help or call county Board of Elections for assistance.

- ◆ Obtain from B. of Elections or www.ncsbe.gov
- ◆ Include full name, residential address, ID number, signature
- ◆ Mail, fax, email, or hand deliver to County B. of Elections
- ◆ Check status at www.ncsbe.gov
- ◆ Near relative or legal guardian may sign and submit request

Last day for B. of Elections to receive ballot request:
7 days before election

Step 2: Receive Ballot

- ◆ County Board of Elections will mail ballot and return envelope
- ◆ Mark your ballot secretly in presence of two witnesses or one notary
- ◆ Only a family member, guardian or Board of Elections Team can help mark ballot

Step 3: Return the Ballot

- ◆ Put ballot inside return envelope and have witnesses sign on back
- ◆ Complete all requested information on envelope
- ◆ Mail or carry envelope to County BOE or to Early voting site
- ◆ Confirm that ballot was received

Last day to deliver or postmark absentee ballot: **Election Day**

Statewide Primary

- ◆ January 25, Monday: Absentee Voting by Mail Begins.
- ◆ February 19, Friday: Voter Registration Deadline.
- ◆ March 3, Thursday: Early Voting Begins. One-stop voting begins.
- ◆ March 8, Tuesday: Last day to request absentee ballot by mail.
- ◆ March 12, Saturday, 1pm: Early voting closes. One-stop voting ends.
- ◆ Tuesday, March 15, 5pm: Absentee Ballot return deadline.
- ◆ Tuesday, March 15: Primary Election Day



General Election

- ◆ September 9, Friday: Absentee Ballots by mail will be available.
- ◆ October 14, Friday: Voter Registration Closes.
- ◆ October 27, Thursday: Early Voting and One-stop voting begins.
- ◆ November 1, Tuesday, 5:00 p.m.: Last day to request Absentee Ballots by mail.
- ◆ November 5, Saturday, 1:00 p.m.: Early Voting and One-stop voting ends.
- ◆ November 8, Tuesday, 5:00 p.m.: Absentee Ballot return deadline.
- ◆ November 8, Tuesday: Election Day.



NC Voter Laws 2016

- ◆ Photo ID
- ◆ Changes to early voting
- ◆ No same day registration
- ◆ No straight party voting
- ◆ No out-of-precinct voting
- ◆ No pre-registration for 16.
- ◆ Register 17 if 18 by Nov. 8, 2016
- ◆ Changes in absentee voting
- ◆ Poll hours controlled by NC-BOE
- ◆ More poll observers
- ◆ Candidates names on ballots by governor's party
- ◆ Increase in contribution limits
- ◆ No more "Stand by your Ad"

Voter ID Requirements

2016 “Valid” photo ID required

- ◆ NC Driver’s License or Learner’s permit
- ◆ NC Non-driver’s License
- ◆ US passport
- ◆ US military or veteran ID
- ◆ Tribe enrollment card
- ◆ Out-of-state Driver’s ID only within 90 days registration
- ◆ *Student IDs NOT “valid”*

IN 2016, YOU WILL NEED A PHOTO ID TO VOTE IN NC

Voter ID Details

- ◆ Seniors: ID that was valid at their 70th birthday can be used for life even after it expires.
- ◆ A NC driver's license or ID from the DMV may be used up to 4 years after it expires.
- ◆ The military or veteran's IDs do not need an expiration date (they are current up to 8 years after the issuance date).
- ◆ The ID's address does not need to match the registration address; the ID is to verify identity, not address.

Exceptions to Photo ID Requirements 2016

- ◆ Declaration of Reasonable Impediment: sign form stating a reason that prevented voter from getting an acceptable ID.
- ◆ Reasonable Impediments: lack of transportation, necessary documents, work schedule, disability/illness, family obligations, natural disaster, lost/stolen ID, application submitted.
- ◆ Provide birth date and last 4 of SSN *or* show a Voter registration card, utility bill, bank or gov. document with name and address.
- ◆ **PROVISIONAL BALLOT:** cast a provisional ballot that will be counted.
- ◆ Curbside voters: people who have difficulty reaching voting room due to age or physical disability.
- ◆ Religious objection: people who have religious reasons for not wanting to be photographed. Need to file a declaration with county 25 days before election. If not filed Provisional Ballot.
- ◆ Provide birth date and last 4 of SSN *or* show a Voter registration card, utility bill, bank or gov. document with name and address
